The Government of Kenya has received financial assistance from the International Fund for Agricultural Development (IFAD) and the Spanish Trust Fund towards financing an eight year (2012-2020) Upper Tana Natural Resources Management Project. The goal of the project is to contribute to rural poverty reduction in the Upper Tana River Catchment through two development objectives namely: (a) increased (b) sustainable food production and incomes and sustainable management of natural resources for provision of environmental services. The Project Lead Agency is the Ministry of Water and Irrigation. The project area is six counties namely: Embu, Meru, Tharaka Nithi, Nyeri, Kirinyaga and Muranga.

The project plans to use part of the funds to procure pipes and fittings for implementation of successful Community Water Projects in the project area as per the approved project AWPB 2017/18FY counties.
