COMMENTS/ISSUES THAT WERE RAISED

During the two days site visits, the following were the concerns/issues tjat were raised which needed to be to enable bidders respond adequately:-

- 1. Gravel packs is not provided for in BOQ
- 2. Borehole development is not provided for in BOQ
- 3. There is no provision for temporary casing
- 4. There is no provision for water for drilling
- 5. 4KW/5HP motor cannot pump 6m³/hr at head of 320m/300m/250m/230m/270m
- 6. No drawings provided for power house & concrete raised water tower.

In conclusion, prospective bidders were informed that these issues were to be addressed by close of business on 26th April 2019.

5	4KW/5HP motor cannot pump 6m³/hr at head of 320m/300m/250m/230m/270m	Supply and install a submersible pump (4.0 KW/5 HP three phase) complete with motor capable of discharging between 3-6m³/hr against a head of 320m/300m/250m/230m/270m
